Reports

Manager's Report

W Bearth reported that the piezo meters have been drilled in the aprons in front of the garages, and grouted caps are scheduled to be installed tomorrow. W Bearth reported that the property has been winterized, including installing snow poles, bobcat maintenance, and heat checks. W Bearth reported that CBL intends to build sand boxes to contain the gravel used for the driveways.

Financial Report

W Bearth reported \$241,109 in available cash as of October 31st, 2020. She also reported that fiscal year to October 31st, the association is over budget by \$906, but that is due to the timing of the audit invoice and should equal out in time.

Operating Account Reallocation

W Bearth reported that the association has a large operating account balance and inquired if the Board had any interest in reallocating some funds to the capital account. The Board directed CBL to research a \$50,000 and \$75,000 CD with a maturity of 12 months and email the Board the findings.
