- 2.) Observed the installed corrugated metal siding. Minor trim work remains.
- 3.) The metal cap around the deck perimeter is being installed.
- 4.) Reviewed the installation of a new concrete footer below the deck. Mick will provide pricing for the single footing and also for 3 additional footers for the remaining deck piers.
- 5.) Reviewed the installation of the Upper Level Hot Tub gate.
- 6.) Lower level hot tub, steps and handrail are installed.
- 7.) Awaiting metal guardrails and handrails.
- 8.) 3 workers were on site including Mick.
- 9.) The work area is consolidated and out of the way of Owner traffic.
